## ADDITIONAL INSTRUCTIONS

- ***All students testing must be current on annual dues.***
- Everyone participating in testing, including testers and assistants, must wear a clean **WHITE** Gi with name and patch.
- Testers should end the test as scheduled and clear the floor in preparation for the next test.
- If the test has a large number of students, then additional helpers (Black Belts) are welcome to be part of the specific test.
- As a courtesy to the testing instructor, please include a copy of a student's written test, if applicable, stapled to the student's test form, or you can email a copy of the written test to the tester prior to testing (ideally a week before).

## PAPERS/FORMS

- BROWN BELT/ONE BLACK STRIPE - send to tester two weeks prior to test. Email address is under name (Brown Belt and above)
- TWO BLACK STRIPES - as a courtesy to the tester, notify them two weeks prior via writing, phone or email of your intentions to test.
- BLACK BELT and DAN CANDIDATES – submit paperwork (information form) to [cnomaa@cuongnhu.com](mailto:cnomaa@cuongnhu.com) and pay test fee (none for Shodan) online.

***Note: Late papers will receive an automatic one-month probation***

## TEST PROCEDURES

- All test results should be filled out on the current test forms
- Any student coming to the test more than 10 min late, will receive an automatic 1-month probation.
- All students are required to break boards within the required trials. A student may be afforded one opportunity to re-break boards, at the testers choosing, if that student would pass the test.
